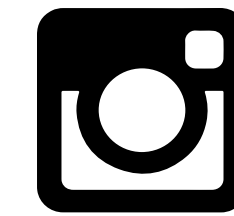


PI Industry Trends – Idaho

The ongoing Covid19 pandemic has been disruptive to the private investigations industry.

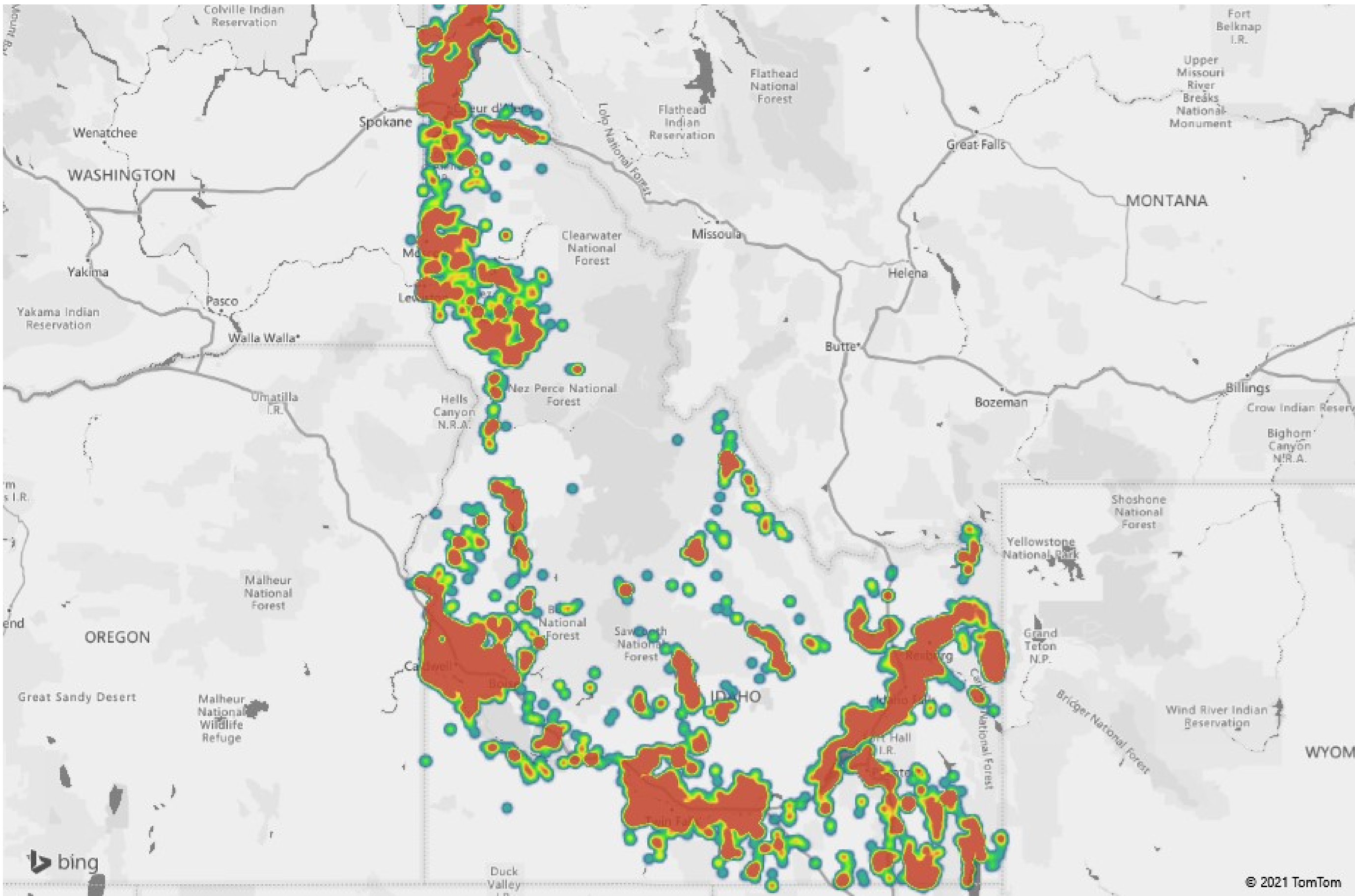

Section 1: Aggregate PPP Loan Data

The Paycheck Protection Program (PPP) program was launched in 2020 through the CARES Act. The program allows entities to apply for low-interest private loans to cover payroll and other costs.

The data to the right details the aggregate totals of PPP loans for all classifications of industries that received PPP loans during the Covid19 pandemic as of June 2021.

Except for total PPP loans and Jobs retained, data is reported in Millions (MM). Data detailed below is by Industry Sector.*

The industry sector that received the most PPP loans was Construction. The total amount of loans received by the industry was 7,207.

The industry sector that received the most total loan amounts was Construction. This industry was awarded a total sum of 556.19 MM in PPP loans.

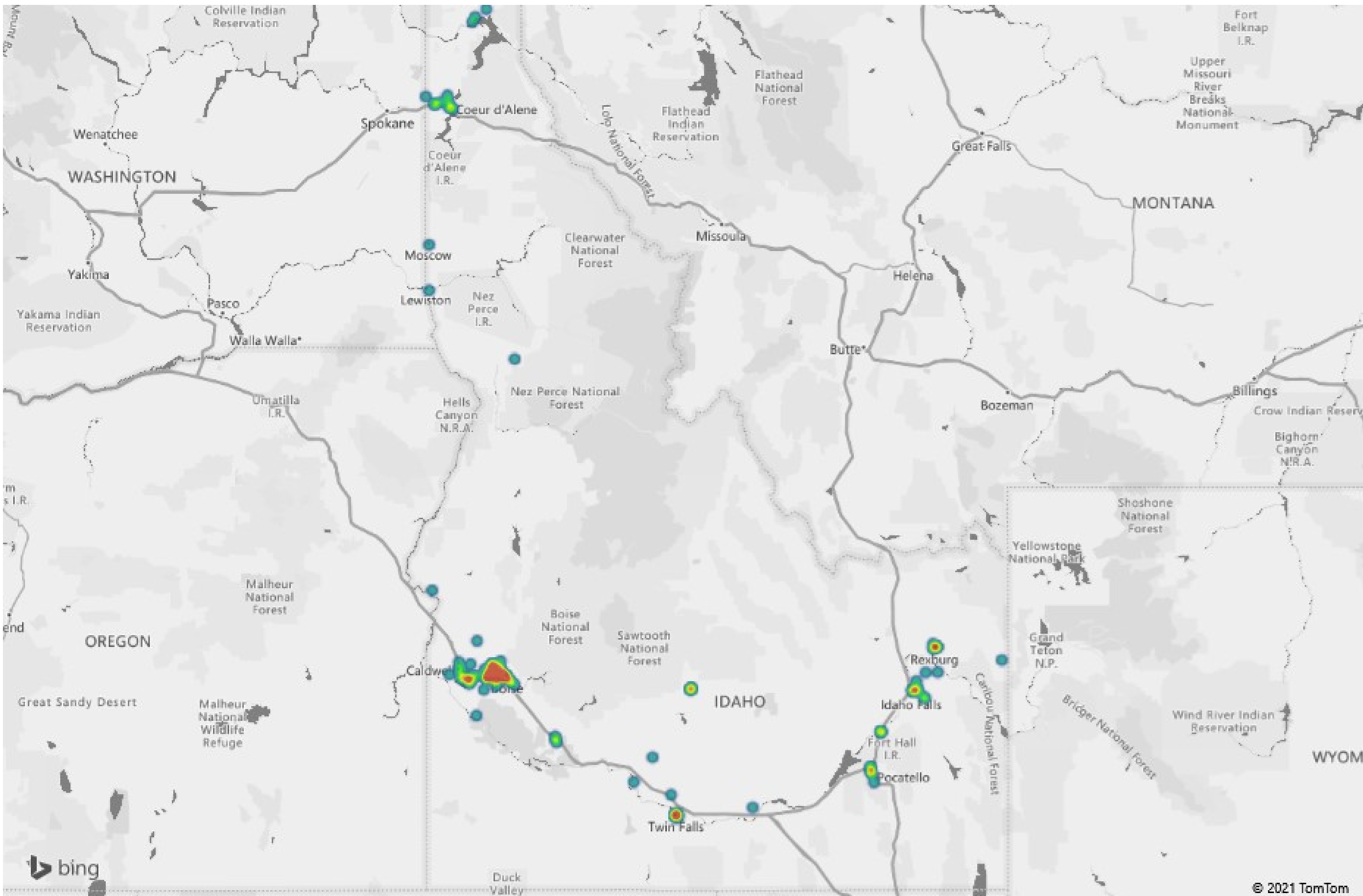
The industry sector that reported the most jobs retained was the Accommodation & Food Services Sector. The total amount of jobs reported retained in this sector was 67,869.

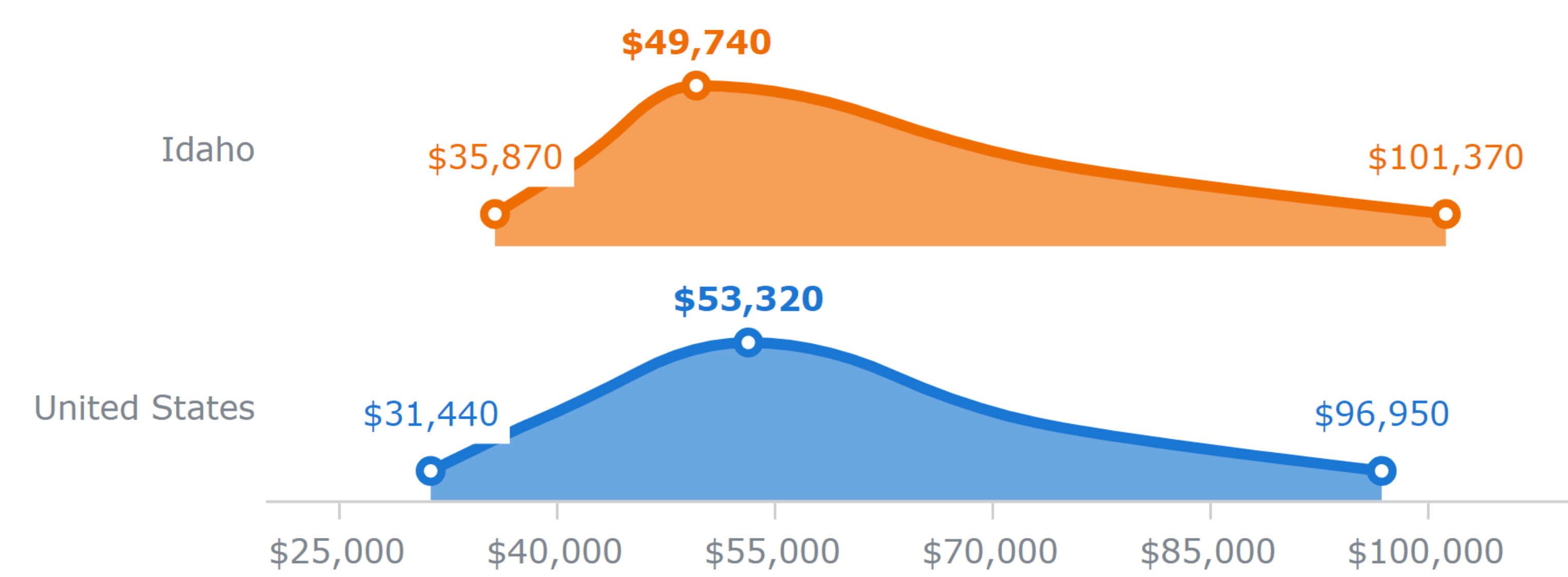

Wage Trends

The data shows the average expected annual earnings for a private investigator in this state as of May 2020. The data indicates that the lowest 10% income earners make about \$35,870 in a given year while the top 90% income earners make about \$101,370.

PI Industry Projections

Industry Trends

Limited information was located for private investigator trends in the state of Idaho. Based on our projections, we expect there to be approximately 150+/-25 active private investigators in the state of ID.

It is not clear how much the industry may have contracted due to the COVID19 pandemic. Based on information from other states, we expect that the industry contracted by approximately -5% +/-2%.
